



## **Analytical Chemist**

Dow Development Laboratories is a contract topical drug product development service provider, with facilities located in Petaluma, CA. We are currently seeking qualified individuals for an Analytical Chemist role.

All ranges of candidates will be accepted and reviewed for this opening. The specific level of the role (i.e. Analytical Chemist I to Analytical Chemist IV) will be determined during the interview process based on knowledge, skills and experience.

The Analytical Chemist performs routine laboratory testing, provides interpretation of results and works under the supervision of others. They will support the development of new processes, procedures and analytical methods. They may test raw materials, in-process materials, and finished pharmaceutical products using physical, wet chemistry, and instrumental techniques. In addition, the Analytical Chemist will summarize laboratory results and maintain laboratory facilities and equipment. They will document laboratory work in compliance with regulations while preparing draft documents and technical reports.

Successful individuals will have the ability to independently perform and document laboratory work as well as identify problems and provide troubleshooting of analytical methods and equipment. They may interpret data, compare data to specifications, assist in experimental design and/or protocol development, and prepare reports for laboratory test results. Accurate calculations and documents will be performed in compliance with GLP/cGMP procedures.

At a minimum candidates will have an Associates or Bachelor's degree in a scientific field with extensive coursework in chemistry or equitable job related experience. Knowledge of laboratory apparatus and equipment is required. Preferred candidates will have a Bachelor's degree in Chemistry, or related scientific field, plus three or more years working experience in a pharmaceutical analytical laboratory environment, or equivalent experience. Successful candidates will have expert analytical laboratory skills including pharmaceutical Quality Control techniques and will have the demonstrated ability to maintain a safety and quality focus.

This individual must be able to effectively communicate with the Supervisor and project team members. They must be willing to learn and follow directions while working independently and as a part of the team. The ability to work with computers (including Microsoft Word and Excel) is also required. Successful candidates will possess strong problem resolution, be organized and work well under pressure in a dynamic environment.

Candidates may be required to move items weighing up to 25 pounds. They must have sufficient manual dexterity to perform laboratory and cGMP operation in a manner to provide precise and accurate results while working in a safe manner. The Analytical Chemist is required to stand for long periods of time to perform laboratory work and have suitable vision for performing detailed inspections.
